Established in 1981, Central Academy for State Forest Service (CASFOS), Dehradun is a premier Institute under the aegis of Directorate of Forest Education, Ministry of Environment, Forest & Climate Change, Government of India, with a mandate of imparting training on forestry, wildlife and environment. The Academy is equipped with latest state-of-the-art facilities for effective training in forestry sector and conducts following types of trainings:

# Introduction to the Course

India is a country blessed with a very rich biodiversity owing to different types of ecosystems spread across the length and breadth of the country. According to India State of Forest Report - 2019, the forest cover of India is 7,12,249 sq.km which is approximately 21.67 percentage of the total geographic area. About 200 types of forests ensure maximum diversity of flora and fauna making India one of the seventeen Megadiverse countries of the world. Increase in human population combined with development needs is mounting immense pressure on the natural wealth thereby threatening ecological security of the country. There is an urgent need to promote sustainable development through conservation of natural resources. The higher educational institutions play a major role in sensitizing the youth to important issues in the society like conservation needs. The teaching faculty of colleges have the capability of channelizing the enthusiasm and energy of the youth towards sustainable nation building and conservation of our forests and environment. Keeping this in view, the training course aims to orient and sensitize the teaching faculty of higher education institutions like colleges to percolate the message of conservation among their students so that conservation is effected at the grassroots level.



#### Course Design

The course is designed for two days to be delivered through online platform MS Teams. Each session of 90 minutes focusses on issues and opportunities in the filed of conservation. The resource persons consists of eminent and experienced speakers including IFS officers, academicians, scientists and subject matter experts. Training materials like soft copies of the presentations and materials provided by the resource persons and other relevant reference materials shall be provided to the participants. At the end of the two day's course, the participants with appreciable attendance shall be given course completion certificate.

### **Objectives of the Course**

- To sensitize the teaching faculty of higher education Institutions towards the issues and challenges in conservation of forests, wildlife and biodiversity in India
- To orient the teaching faculty in such a way that the message of conservation is spread among the students who are the larger and active part of the society.
- To foster partnership between Forest Department and the Academia to achieve the larger goal of conservation.
