**INTRODUCTION: -**

The Ph.D. Entrance Test (PET) for admission to Doctor of Philosophy under the Faculty of Homoeopathy subjects for academic year 2021 will be conducted by the SGGU

**Eligibility: -**

A candidate, who fulfils the following criteria, shall be eligible to appear for the Entrance Test, namely: -

- I. He is a citizen of India;
  - II. He has studied and passed in the course(s) leading to the award of PG degree in respective branches recognized by respective councils and Government of India and affiliated to any University established by Law; and
2. The candidate willing to register for Ph.D. program as Ph.D. Scholar, shall fulfil the eligibility conditions as mentioned in Clause of University.

**3. Instructions for Filling Application Form: -**

- I. Candidate should have a valid E-mail Id and correct Mobile number.
- II. Before filling Application Form candidate must possess the required criteria and educational qualification as mentioned above.
- III. Candidate shall submit only one application form, if candidate submits more than one application then, the previous application will be rejected and latest application submitted by the candidate shall be considered.
- IV. Eligible Candidates seeking admission to the Ph.D. program must submit their application to the University on or before **15<sup>th</sup> June 2021**.
- V. Candidate must submit the hard copy of the printed application form with self-attested all necessary documents as prescribed by the University on or before 15/06/2021 by post or in person at the following address-  
***"The Registrar, Shri Govind Guru University, Govt. Polytechnic Campus, RTO Road, Gadukpur, Godhra-389001.***
- VI. The application must be highlighted as **"APPLICATION FOR Ph.D. ENTRANCE TEST (PET)-2021" (Academic Section)** on the top side of envelope. Incomplete applications, in any respect, shall be rejected and no complaint or queries shall be entertained in this regard, therefore, it is the responsibility of the candidate to ensure that the application for the PET is complete in all respect and is supported by necessary attachments.



- VII. The admission of the Candidates for Ph.D. Degree shall be on the basis of Merit of Entrance test conducted by the University and Roster of Government of Gujarat.
- VIII. The in-service Candidates applying for full-time / part-time Ph.D. programs shall have to submit "No Objection Certificate" from their employer in the prescribed format as the case may be.
- IX. Reservation policy will be followed for admission as per the existing rules of the Gujarat Government. The Physically Disabled candidates may claim reservation by producing valid certificate to that effect issued by the competent authority. There will be seats (subject-wise) reserved for persons with disabilities as per the Govt. of Gujarat rules.

**Registration Fee:**

**Mode of Payment:** - All the Candidates need to pay Entrance Test Registration fee (Non-refundable) of Rs. 2500/- for Open Category and Rs. 1500/- for reserved Category by **Demand Draft (Shri Govind Guru University Examination, Godhra Payable at Godhra) or Deposit in Axis Bank A/c. No.918010086166147, IFSC Code:UTIB0000264, MICR:389211002**

**4. Examination Centre: -**

The University will conduct PET Examination at Godhra only.

**5. Issuance of Admit Cards:**

Admit Cards for PET-2021 appearing candidates will be made available on the University website 15 days before the examination date. For downloading the Admit Card, candidate is required to login into University website. It shall be the responsibility of the candidate to download the Admit Card. Candidates has to come with this printout of the Admit Card at the time of the Entrance Test. Candidates without Admit Cards will not be allowed to enter the Examination hall. Details of date of examination, time and venue shall be informed on Admit Card provided for Entrance Test (PET - 2021).

**6. Identity Verification: -**

In the examination hall, the Admit Card along with original of the candidate's photo identity (bearing reasonably the same name as it appears on the Admit Card) such as PAN Card / Indian Passport / Driving License / Voter's Card / Bank



Passbook with Photograph/ Photo identity proof issued by a Gazetted Officer on official letterhead along with photograph / Photo identity proof issued by a People's Representative on official letterhead along with photograph / recent Identity Card issued by a recognized School / College/ Aadhaar Card/E- Aadhaar Card print with a photograph/ Photo Identity Card (of Central Govt./PSU or State Govt. /PSU only) should be shown to the invigilator for verification. The candidate's identity will be verified with respect to his/her details on the Admit Card, in the Attendance List and requisite documents submitted. If identity of the candidate is in doubt the candidate may not be allowed to appear for the Examination.

**7. Pattern and Syllabus for the Entrance Test (PET- 2021): -**

**Pattern of Examination**

Paper 70 Marks	:	Research Methodology (35 MCQ each of 01 marks) Homoeopathy Subject Knowledge Test (35 MCQ each of 1 marks)
Interview 30 marks	:	



- I. Entrance Test shall be conducted in **offline mode** only.
- II. The Entrance Test will consist of one question papers each of 90 minutes of duration.
- III. There will be **no negative marking** for wrong answers.
- VI. All questions are compulsory.
- VII. Re-evaluation and Photocopy facility for PET is not available and request for the same will not be accepted.
- VIII. There will be no grace marks for Entrance Test. Language of the entrance examination shall be English only.

**8. Exemption from PET Examination: -**

The candidate who has qualified AYUSH NET Examination in a relevant subject will be exempted from Entrance Examination. However, the candidate who is exempted from Entrance Exam is also instructed to fill the application form and submit it with all required documents to the University.

**9. Preparation of Merit List: -**

Merit list shall be prepared of those candidates appearing for Entrance Test (PET-2021). The said merit list shall be used for the process of provisional Admission. The Entrance test shall be qualifying test with 50% qualifying marks for Open category candidates and 45% qualifying marks for Reserved Category candidates. The Open category candidates and Reserved Category candidates need to score minimum 50% and 45% marks respectively to qualify for preparation of merit list.

**Tie-Breaker**

In case of equal marks in Entrance Test the following procedure shall be adopted for deciding the merit.

**First level: -**

The candidate with more aggregate marks (converted into percentage up to 2 decimal points) at post-graduation.

**Second Level: -**

The candidate with more aggregate marks (converted into percentage up to 2 decimal points) at graduation.

**Third Level: -**



If the tie still persists then an older candidate will be preferred over the younger candidate.

**10. Selection Process: -**

- I. Allotment list of the Ph.D. Center shall be published on the University website. The Candidate shall finalize his admission in the allotted Ph.D. Center and submit his retention form, along with necessary documents and the notified fees, within the time schedule published by the University.
- II. The selected candidate shall join concerned research center and take the admission for Ph.D. program. If the selected candidate is unable to join within stipulated period due to any reason, the seat will be considered vacant (University reserve the right for further process).
- III. At the time of admission, the selected candidate shall pay the prescribed fees for admission and shall complete the other procedures related to his/her admission.

**11. Provisional Registration Process: -**

The date of the joining of the candidate at Research Centre shall be treated as Provisional date of Registration. However, the actual term of candidate shall be deemed to start from the date of approval to the Synopsis.

**12. Disclaimer: -**

- I. PET- 2021 is only Qualifying Examination. No PET- 2021 qualified candidate can claim automatic registration for the Ph.D. program.
- II. It shall be the responsibility of the candidate to check whether he/she fulfils the eligibility conditions for the Ph.D. registration. University shall not be responsible for any lapses thereof.

**13. Warning: -**

In case, any candidate is found to have submitted false information or Certificate(s) etc. or is found to have concealed or withheld some information in his/her application form, then he/she shall be debarred from admission.




Any other action that may be considered appropriate by the Vice-Chancellor of the University may also be taken against him/her, which may include criminal prosecution also.

14. **Admission Grievance Committee:** - The Admission Grievance Committee setup under the Chairmanship of the Competent Authority. It shall deal with the representations submitted by the candidate(s) related to Ph.D. admission grievances, if any.

**Note:**

1. In case, any Candidate, who is Ph.D. Guide or Research Supervisor of the University and intends to seek admission for Ph.D. degree, he shall not enroll any Ph.D. student under him till he completes his Ph.D. degree. It is his responsibility to communicate to the University that, he is seeking admission to Ph.D. course so as not to allocate the students.
2. Intake capacity indicated against the respective research center may vary (increase or decrease) at any stage.
3. Before admission process, it is mandatory for all Ph.D. centers to get continuation of affiliation, if not done earlier.
4. The University reserves the right to change, alter any rule and Examination schedule regarding admission procedure.
